Board certification is a voluntary process for those physicians who choose to pursue certification.

In addition to offering board certification in the obstetrics and gynecology specialty, ABOG also administers board certification in five subspecialties:

- Complex Family Planning
- Gynecologic Oncology
- Maternal-Fetal Medicine
- Reproductive Endocrinology and Infertility
- Urogynecology and Reconstructive Pelvic Surgery

To define standards, certify obstetricians and gynecologists, and facilitate continuous learning to advance knowledge, practice, and professionalism in women's health.



ABOG also offers a public website called **OB/GYN Health+**. Its mission is to serve as a resource for OB GYN patients, inspired by the American Board of Obstetrics and Gynecology's quest to help them live their best lives. ### VOICE

introductory meetings with our Pediatric and Adolescent Gynecology (PAG) colleagues as we move toward PAG subspecialty application, so that as an allied force we more vigorously address the needs of our country's pediatric and adolescent patients. Lastly, we expanded access to our volunteer opportunities to better represent the voices and diversity of our diplomates and the patients we serve.

**MASTERY** 

Finally, we come to mastery, which speaks to the vast knowledge that is integral to the practice success of residents, specialists, fellows, and subspecialists from residency to retirement. As clinically active diplomates, we know the diligent work that goes into caring for patients, particularly in an era that bears witness to faster advances in medicine. ### ABOG Approves AAGL's EMIGS Training and Testing Program as Option to Meet Surgical Skills Program Standard

ABOG approved the American Association of Gynecologic Laparoscopists (AAGL) Essentials in Minimally Invasive Gynecologic Surgery (EMIGS) Training and Testing Program as an alternative option for candidates to meet the Surgical Skills Program standard for ABOG certification, which was initially announced in 2018.

This standard is part of a broader initiative by ABOG to incorporate simulation and standardize the knowledge and training completed by OB GYN residents. It also establishes an additional objective measure for all U.S. obstetricians and gynecologists applying for specialty certification.



# **News Highlights**

### Dobbs vs. Jackson Women's Health Organization Anniversary Statement

On June 24, 2022, the Supreme Court of the United States issued the *Dobbs vs. Jackson Women's Health Organization* decision that overturned decades of constitutionally protected abortion access in the United States. This decision and subsequent changes in state laws have resulted in restricted rights to, access to, and provision of reproductive health care and abortion to the people served by obstetricians and gynecologists throughout the country. The decision has also led to regional variability in access and practice as well as created disparities in care and outcomes.

The patient-physician relationship has been strained as patients and physicians struggle to access and deliver evidence-based care. Pregnant patients have been denied timely and vital care until they develop severe, lifethreatening complications that would have been prevented by early interventions. Patients must trust that their physicians can and will provide critical health care without legislative interference in personal decision making.

ABOG joins that collective voice of our specialty, board-certified diplomates, and the people we serve to reiterate its commitment that comprehensive family planning including abortion are essential to the practice of OB GYN, the patients that place their trust in us, and public health of our country.

### ABOG and ABU Rename Subspecialty to Urogynecology and Reconstructive Pelvic Surgery

ABOG and the American Board of Urology (ABU) announced the name change of the jointly sponsored subspecialty of Female Pelvic Medicine and Reconstructive Surgery (FPMRS) to Urogynecology and Reconstructive Pelvic Surgery (URPS), effective January 1, 2024.



The request for change was approved in June 2023 by the American Board of Medical Specialties (ABMS). The joint proposal went through a period of open public comment,

review by the ABMS Committee on Certification, and approval by the ABMS Board of Directors.

ABOG and ABU requested this change to more accurately describe the subspecialty and adopt a name that is more recognizable to the public, patients, and referring health care providers.

"Ultimately, the goal of this name change is to make it easier for patients to find the care that they need," said Dr. Amy Young, ABOG Executive Director, and Dr. George Wendel, former ABOG Executive Director.

### ▶ ABOG Concludes a Successful 2023 Certifying Exam Cycle

The 2023 Specialty CE cycle marked a successful return to inperson exams in Dallas since 2019, with both examiners and candidates present at the temporary ABOG testing facility.

In April, ABOG hosted 122 examiners and 342 candidates for the Subspecialty Certifying Exams. In addition, ABOG welcomed a total of 420 examiners and successfully administered the exam to 1,452 candidates for the Specialty Certifying Exam over four non-consecutive weeks from October through December.

"The ABOG staff works tirelessly to ensure we develop and administer fair assessments, incorporating defensible processes that are seamless for both candidates and examiners," said Pooja Shivraj, MS, PhD, Chief of Assessments. "We strongly believe our 2023 Certifying Exams maximized opportunities for fairness in every capacity to support women's health care."

ABOG extends its gratitude to all examiners for their dedication and time, and candidates for their unwavering dedication to their patients and profession by joining the elite ranks of board-certified physicians. Earlier in 2024, ABOG was excited to host its first cycle of exams in its new center, which opened in January 2024.

"The new facility is a testament to the ABOG Board and previous executive directors who had the vision to build toward a new future for women's health care. We have built an incredible center to convene, educate, and certify obstetricians and gynecologists to promote safer care for women," said Amy Young, MD, Executive Director.

# ABOG Completes Construction of National Center for OB GYNs

ABOG completed construction on its new facility in 2023.

Constructed over a two-year period, the new facility reflects ABOG's dedication to meeting the demands of today's complex and technology-focused certification processes and programs and is a testament to ABOG's commitment to advancing health care in the OB GYN community across North America.

Originally built in 1980, ABOG's previous testing center was purchased in the mid-90s upon moving its headquarters from Seattle, Washington to Dallas, Texas. ABOG was one of the first medical certification boards to move its oral Certifying Exams from hotels to a professional testing center location.

The aging infrastructure of the 40year-old building posed challenges, including increased maintenance costs and inefficiencies in energy usage and technology delivery.

The new center enhances ABOG's ability to conduct certifying exams, item writing sessions, and large meetings with greater efficiency and effectiveness by providing increased capacity, flexibility, and functionality.

It includes 59 exam rooms, 54 offices, 12 conference rooms, 15 lactation/wellness rooms, and 5 breakout rooms. The new meeting spaces with enhanced technology and flexibilities will help facilitate efficient collaboration to improve the experience of ABOG volunteers, and the audiovisual-equipped exam

rooms, increased number of meeting rooms, orientation center, and wellness rooms will support certification candidates more fully throughout their testing experience.

"I feel very privileged to have this position and to build on the vision of previous executive directors and boards and to take it further into the future," said Amy E. Young, ABOG Executive Director. "The grand opening of our state-of-the-art testing center marks a momentous occasion of a decade-long process. The building not only serves as a hub to build connection and professional identity for our diplomates but also symbolizes a commitment to providing safe care for women nationwide."

# Honoring George D. Wendel, MD

George D. Wendel, Jr., MD, completed his 12-year tenure at ABOG at the end of 2023 as Executive Director.

Dr. Wendel started his career at ABOG as the Assistant to the Director of Evaluation in 2012. In 2013, he became the Director of Maintenance of Certification. From 2017 to 2023, Dr. Wendel served as ABOG's Executive Director, where he was an integral leader in upholding and maintaining ABOG's certification processes and Maintenance of Certification (MOC) program.

Prior to his time at ABOG, Dr. Wendel was a professor in the Department of Obstetrics and Gynecology at the University of Texas (UT) Southwestern Medical School, serving as a faculty member for 30 years. He was the Director of the Senior Medical Student Clinical Clerkship from 1986 through 1994 and the Residency Program Director from 1994 through 2012. He held the Bud Brekken Professorship and Norman Gant Chair and was the department's Vice-Chair for Education. Dr. Wendel's academic research expertise lies in the areas of infectious disease, STIs and HIV in women and pregnancy, maternal and perinatal infections, and drug addiction in pregnancy.

He was previously a consultant to the Centers for Disease Control and Prevention, the NIH, and the NIAID regarding STI treatment guidelines and bioterrorism response and preparedness.



He was a member of the ACGME Residency Review Committee for Obstetrics and Gynecology from 2007 to 2012 and served as Chair for three years.

Dr. Wendel was an ABOG Specialty

Certifying Examiner from 1995 through 2012 and a Maternal-Fetal Medicine (MFM) Examiner from 1996 through 2007. He was a member of ABOG's MFM Division from 2000 through 2004, served as the MFM Division Director and Chair of the Subspecialty Committee from 2004 through 2007, and served on the ABOG Board of Directors from 2004 to 2012.

Dr. Wendel graduated from St. Louis University Medical School, earning his degree in 1978. Following that, he completed his residency in obstetrics and gynecology in 1982 and his fellowship in Maternal-Fetal Medicine in 1984 at UT Southwestern Medical School. Dr. Wendel became board-certified in obstetrics and gynecology from ABOG in 1985. He became MFM board-certified from ABOG in 1987.

ABOG would like to thank Dr. Wendel for his dedication and hard work over the last decade. He led the organization in improving its certification processes for OB GYNs to help improve women's health. We cannot thank him enough for all the work he did. He will be greatly missed at ABOG, and we wish him all the best.

### **Education Grants**

For the 2023-2024 academic year, ABOG awarded a total of \$415,000 in grants to fund research fellows and to provide assistance to scholars in their research and career development.

These philanthropic initiatives organize educational opportunities, including scholarships and seminars relating to the obstetrics and gynecology (OB GYN) field for both existing physicians and students.

### ► THE REPRODUCTIVE SCIENTIST DEVELOPMENT PROGRAM (RSDP)

Launched in 1988, RSDP is a national career development program with the goal of developing a body of reproductive physician-scientists based in academic departments who could employ cutting-edge cell and molecular technologies to address important problems in the OB GYN field.

In 2023, ABOG awarded **\$25,000** per scholar (**\$100,000** total) for research-related expenses:

# **Gilstrap and NAM Fellows**

#### **GILSTRAP FELLOW**

ABOG hosted the Centers for Disease Control (CDC) Gilstrap OB GYN Fellow, Meryl Davis, MD, and CDC Health Scientist, Christina Sancken, MPH, CHES, in July as part of a collaboration to analyze Continuing Certification (MOC) article-based assessment questions.

This analysis focused on CDC articles distributed by ABOG in the 2022–2023 MOC years. Topics include syphilis, COVID-19, influenza, and mpox. Results from this analysis will inform the future efforts of the two organizations in pursuit of improving women's health and health care.

#### NATIONAL ACADEMY OF MEDICINE FELLOW

In August, the National Academy of Medicine (NAM) selected the Norman F. Gant/ABOG fellow for the class of 2023 NAM Fellowships: Michelle Debbink, MD, PhD.

ABOG-certified in OB GYN and Maternal-Fetal Medicine, Dr. Debbink is an assistant professor in the Department of Obstetrics and Gynecology at the University of Utah School of Medicine, Salt Lake City, and is the Vice Chair for Equity, Diversity, and Inclusion in the Department of Obstetrics and Gynecology at the University of Utah Health Sciences Center. She currently serves on the ACOG Committee on Indigenous Health, the Society for Reproductive Investigation's Diversity, Equity, and Inclusion Committee, and Utah's maternal mortality review committee (MMRC).

Dr. Debbink plans to build a research program that results in meaningful

change in the maternal mortality and morbidities that Native Hawaiian/Pacific Islander (NHPI) and Native American/Indigenous communities face in Utah.

The Gant/ABOG Fellowship is awarded for a two-year period. During this time, the fellow is expected to continue to work at their main academic post, while being assigned to a health- and medicine-related board of the National Academies.







### ▶ 2023 Revenue




### ▶ 2023 Expenses

**▶ DIPLOMATE GEOGRAPHIC DATA** BY STATE (n = 38,198)



## **Certification Overview**

In 2023, ABOG administered Specialty (OB GYN) and Subspecialty (Complex Family Planning (CFP), Gynecologic Oncology (GYN ONC), Maternal-Fetal Medicine (MFM), Reproductive Endocrinology and Infertility(REI), and Urogynecology and Reconstructive Surgery (URPS)) Qualifying and Certifying Exams to over 3,800 OB GYN physicians.

### **▶ Initial Certification Process**

The Job Task Analysis starts the process of creating a blueprint for ABOG's two-step certification process outlined below.

The process is cyclical to ensure rigor and relevance of the specialty.



### **▶ 2023 SPECIALTY QUALIFYING & CERTIFYING EXAMS**


Pass Rates: Overall and First-Time Takers (FTTs)


### **▶ 2023 SUBSPECIALTY QUALIFYING EXAMS (QE)**

#### **CFP SENIOR CANDIDATE EXAM EXTENSION**

In 2023, ABOG received ABMS approval to extend the Complex Family Planning (CFP) Exam. With this extension, a final senior candidate exam will be given mid-2025.

#### **URPS NAME CHANGE**

The request to change the name of the jointly sponsored subspecialty of Female Pelvic Medicine and Reconstructive Surgery (FPMRS) to Urogynecology and Reconstructive Pelvic Surgery (URPS) was approved in June 2023 by the American Board of Medical Specialties (ABMS). The joint proposal went through a period of open public comment, review by the ABMS Committee on Certification, and approval by the ABMS Board of Directors.

ABOG and ABU requested this change to more accurately describe the subspecialty and adopt a name that is more recognizable to the public, patients, and referring health care providers.

ABOG and ABU FPMRS certification was approved in 2011, and the first subspecialists were certified in 2013. Approximately 1,700 subspecialists have achieved this certification by the two boards. Subspecialists must also be specialists in the fields of obstetrics and gynecology or urology, and they seek subspecialty certification after completion of Accreditation Council for Graduate Medical Education (ACGME) accredited fellowship programs.

"Ultimately, the goal of this name change is to make it easier for patients to find the care that they need," stated Dr. Amy Young, ABOG Executive Director, and Dr. George Wendel, former ABOG Executive Director.



# Continuing Certification (MOC) Overview

The Continuing Certification (MOC) program is a continuing professional development process to support ABOG-certified physicians as they maintain a high level of knowledge, judgment, and skills in Obstetrics, Gynecology, and Women's Health throughout their careers.

A total of **36,793** diplomates completed the 2023 MOC year. Of those, **30,468** diplomates are certified in OB GYN and **6,325** are also certified in an ABOG subspecialty: CFP, GYN ONC, MFM, REI, URPS. Additionally, **1,160** diplomates have Focused Practice Designations (FPDs) in MIGS or PAG.


TOP 5 MOST POPULAR ARTICLES

The Lifelong Learning and Self-Assessment component contributes to better patient care by requiring ongoing participation in high-quality learning activities that assess current knowledge in obstetrics and gynecology and its subspecialties.

Part II consists of article-based assessments from peer-reviewed literature on clinically relevant patient-management information, best-practice guidelines, and important research and studies.

Diplomates read 15 articles and complete assessments in the categories of General Obstetrics, Gynecology, Office Practice, Pediatric and Adolescent Gynecology, Minimally Invasive Gynecologic Surgery, the five subspecialties, Health Equity and Patient Safety, or any of the other available article categories (for example, Emerging Topics).

In 2023, ABOG delivered approximately 110 article options through our diplomate portal. The top five articles that were chosen by diplomates were in the categories of health equity and patient safety, obstetrics, complex family planning, and office practice.



### ▶ PART IV: PRACTICE IMPROVEMENT TOP 5 MODULES

Practice Improvement contributes to improved patient care through ongoing assessment and improvement in the quality of care in practices, hospitals, health systems, and/or community settings. This may include activities that result in improved patient or population health outcomes, improved access to health care, improved patient experience (including patient satisfaction), and increased value in the health care system.

Diplomates must choose one activity most relevant to their own practice and practice setting. Below are the top five most popular modules diplomates chose to complete their Part IV requirement.



### NEW INITIATIVES

In 2023, the Continuing Certification Department introduced the following new initiatives to benefit diplomates:

### THE PERMANENT ADOPTION OF THE PART II COVID-19 ACCOMMODATION

During the pandemic, ABOG reduced the number of articles diplomates were required to read annually. Diplomates provided positive feedback, and ABOG officially made this accommodation permanent in 2023.

### PART IV CREDIT GRANTED TO DEA-LICENSED DIPLOMATES

Diplomates can now receive Part IV Practice Improvement credit for their work by obtaining the license from the Drug Enforcement Administration for prescribing drugs/controlled substances.

### SUBSPECIALTY CERTIFYING EXAM CME CREDIT

Diplomates who took and passed the Subspecialty Certifying Exam were given the option to receive CME credit for taking the exam.

### PART IV CREDIT FOR PROGRAM DIRECTORS AND ASSOCIATION PROGRAM DIRECTORS

Diplomates who are Program Directors or Associate Program Directors can now receive Part IV Practice Improvement credit for their role as a PD or APD.

Every year, board-certified OB GYNs dedicate their valuable time and expertise to help with ABOG's OB GYN certification and Maintenance of Certification (MOC) processes.
