Thank you for your interest in the American Board of Obstetrics and Gynecology (ABOG) data. We have a responsibility to protect the confidentiality of the data we provide, including Protected Health Information (PHI), Personally Identifiable Information (PII), and other confidential and/or sensitive information. As such, we will not be able to provide any data that is not deidentified.

To request use of ABOG's data for your purposes, please complete the following form and email it to asparks@abog.org. Completion of this form does not guarantee that any data will be shared.

There are two submission deadlines for data requests annually: April 15 and October 15. Data requests are reviewed twice a year by ABOG's Research and Innovation Committee. Multiple factors are taken into consideration during the review process including, but not limited to, alignment with ABOG's mission, ABOG's resources, and ABOG's current projects, among other factors.

For each of these submission deadlines, you will receive your response by July 15 and February 15, respectively.

Please ensure adequate details are provided in the request form to allow for a thorough review. Incomplete requests will not be considered, will be marked as incomplete, and will be returned.

If your request is approved, please note that you may be asked for more details and to sign an ABOG Data Sharing Agreement. The agreement will have requirements to protect the confidentiality of the data, and it may restrict usage of the data. The agreement will also have requirements for including co-principal investigators, authorship, and/or acknowledgement.

If you are conducting a research study, please also ensure your data/research request aligns with ABOG's research mission and strategic priorities listed below, and that your project requires proof of Institutional Review Board (IRB) approval or exemption prior to submission.
